Due to the observation building being temporarily closed to the public, the Organization had to modify many of their educational programs. In person programs were performed outdoors and the online. The Organization did a series of online and outdoor programs on weather events, tours of the Observatory from the outside and interviews with authors, meteorologists and other scientists. The Organization participated in the Southern New England Weather Conference which is cohsted with the National Weather Service.

The Organization revised their membership programs to include expanded access to the Observatory when the building reopens.
