The Organization observes and records the weather for current and future generations.

The Organization offered a variety of educational programs throughout the year, including a series of outdoor events focused on weather phenomena. These programs featured tours of the Observatory and included interviews with authors, meteorologists, and other science professionals. Additionally, the Organization participated in the Southern New England Weather Conference, which it co-hosts with the National Weather Service.

With the reopening of the Observatory, the Organization has updated its membership programs to offer expanded access to the facility. Members now receive regular communications from the Organization and have the opportunity to purchase books, Observatory souvenirs, educational toys, and science kits. Additional member benefits include exclusive tours of the Observatory, as well as access to volunteer opportunities and internships. These enhancements reflect the Organization’s commitment to providing meaningful and engaging experiences for its members.

Purchases of collection items reduce unrestricted net assets in the period when purchased. Proceeds from deaccessions or insurance recoveries are reflected as increases in the appropriate net asset class. There were not any additions of individual objects to the collection during the year ended August 31, 2024, through gifts, transfers, or purchases. The Organization did not purchase or expense individual objects during the year ended August 31, 2024. There were no deaccessions during the year ended August 31, 2023. As of August 31, 2024, the Organization has approximately \$230,000 of historical artifacts that have not been recorded in the accompanying financial statements.
